Privacy Statements

Access to this information is restricted to authorized staff of the school. Inspire Academy is committed to maintaining the confidentiality, privacy, and security of the personal information it collects. Information Collected and Automatically Stored

The only information involuntarily collected includes general information such as IP address, generic demographics, pages visited, and length of stay. This information is gathered to enhance your visit to our website. No personally identifying information is gathered unless voluntarily given and described at the point of collection in the following instances: to contact the school, to request information, applications, re-enrollment applications, update information, and event registration. If you provide contact information, School staff may contact you to answer your question or comment.

Financial Information

All financial information, such as tuition, school activities, or event payments, is managed by school billing staff with appropriate security methods. Information requested can include name, address and credit card number, and expiration date. We do not share information with outside parties except to the extent necessary to complete the transaction.
